CCFSA welcomed back its Summer Skeet Camp in June 2020. Youth shooters enjoyed three days of skeet instruction and shooting. Eighteen campers, ranging in age from 12 to 18, had various levels of prior experience. Some of the participants were new to shooting sports in general, but still broke plenty of targets by the end of camp.

This year's Skeet Camp was partially funded with grant money, provided by the Ohio Department of Natural Resources and the Ohio Gun Collectors Association partnered with the Sportsmen's Alliance Foundation. CCFSA is extremely appreciative of the generosity from these organizations.

After a safety briefing and introduction to skeet shooting, the campers were divided between three skeet fields according to approximate experience/skill level. Awards were presented to the high scorer for each group on the last day of camp. All of the campers performed extremely well with safety, learning, and shooting during the event.

The camp was coordinated by Cindy Warren, and would not be possible without her efforts. CCFSA is grateful for the help of the additional Camp Instructors, which included Dave Ackerman, Jack Grehan, Carol Tedrick, Richard Tedrick, and Bruce Warren.

# Safety Topic

## Placement of target stands

- Target stands are to be placed as close to the base of the mounds as possible.
- The firing line can move toward the backstop mounds, but you cannot bring the targets away from the mounds
- Do not shoot over the mounds.
- Do not place targets on the mounds.



- Do not use aerial targets or any target other than paper targets attached to target frames.



- During organized shoots other types of targets may be used.



# Safety Topic

## Shotgun Shooters

- Do not pattern your shotgun using club target stands.
- Provide your own target stand, such as a cardboard box, to pattern your shotgun.



- Paper to pattern shotgun available upon request

## Range Cleanup

- Do not leave any trash except in the supplied garbage containers.
- Please pick up shotgun shells used and put into trash cans provided
- Remember we have houses with curious kids near by.
- **Place any live ammo found on the range in the DUD ammo box.**



## **NRA LAWSUIT**

New York's Atty General is suing the NRA, hoping to abolish the 5 million strong 2<sup>nd</sup> Amendment support and training giant. **HB248 Sponsor: Powell, Smith T. What would it do?** Exempt antique firearms from the list of banned weapons under a disability. Last action: 4th hearing 6/3/20

**HB315 Sponsor:** Liston **What would it do?** Mandate that licensed firearms dealers give gun buyers suicide prevention information. Last action: Awaiting first hearing

**HB316 Sponsor:** Russo, Sweeney. **What would it do?** Allow family members or police to seek a court order to temporarily seize weapons from those who appear to be a danger to themselves or others. Last action: Awaiting first hearing.

**HB317 Sponsor:** Robinson, Miller. **What would it do?** Expand background checks for all gun purchases. Awaiting first hearing

**HB319 Sponsor:** West, Miller. **What would it do?** Give local jurisdictions the authority to regulate firearms. Last action: Awaiting first hearing

**HB320 Sponsor:** West. **What would it do?** Bar firearms dealers from transferring guns while a background check is pending, unless 30 days have elapsed. Last action: Awaiting first hearing

**HB349 Sponsor:** Weinstein. **What would it do?** Generally prohibit possession of large-capacity magazines of 10 or more rounds and require registration of legal high-capacity magazines. **Status:** Pending in House Criminal Justice Committee Last action: Awaiting first hearing

**HB381 Sponsor:** Hood, Keller. **What would it do?** Stand Your Ground. Last action: 4th hearing 6/10/20

**HB49 Sponsor:** Greenspan. **What would it**

**do?** Allow CCW permits to be used as ID for voting. **Status:** House State and Local Government Committee approved

**HB658 Sponsor:** Galonski. **What would it do?** Require firearms training for school employees authorized to carry firearms in school safety zones. **Status:** Awaiting committee assignment

**SB182 Sponsor:** Thomas, Lehner. **What would it do?** Raise the purchase age to 21 for all firearms. **Status:** Pending in Senate Government Oversight and Reform.

**Last action:** 2nd hearing 1/21/20

**SB183:** Thomas, Lehner. **What would it do?** Expand background checks for all gun purchases






